FINANCING AVAILABLE : G-MAP and MO STEP=UP

The Missouri Department of Economic Development's International Trade & Investment Office offers two programs: the Global Market Access Program (G-MAP) and the State Trade and Export Promotion Grant Program (MO STEP=UP) to help small and mid-sized MO businesses participate in international missions. Eligible companies may qualify for cost-sharing and/or grants covering up to \$1750 of the \$2500 registration fee in addition to possible hotel and travel costs.

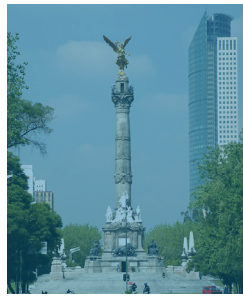
